# **Guests Last Meeting**

Jim Snively Matt (Joe's guest) James was a little envious of an establishment such as Starbucks that has a stable workforce that does the same activity every day. By contrast, the voting system is operated by a very large volunteer staff who need to set up many temporary voting locations (428 in Delaware County) for one or two days a year. An added complication is the recent increase in hostility towards the voting staff by some members of the public.

These complications are addressed by doing a lot of training and contingency planning. There is a multi-

layered security system in place to prevent voter fraud. Because of these systems, James assured us that there is very little voter fraud.

## **Delaware County voter fraud allegations**

I was not aware of it but Delaware County is famous in some circles as a hot bed of election fraud in the 2020 election. A lawsuit alleging that was recently dismissed.

The following is excerpted from the Delco Times, July 21, 2022: "A Delaware County judge dismissed a case alleging fraud in the 2020 general election, according to court documents and county officials. On July 8, Delaware County Court of Common Pleas Court Judge John J. Whelan dismissed the complaint with prejudice, after sustaining the objections in their entirety. On Jan. 1, 159th Legislative District candidate Ruth Moton, Bethel Township Republican Committeewoman Leah Hoopes and Republican election watcher Gregory Stenstrom filed a 104-page complaint alleging common law fraud and negligent and fraudulent misrepresentation related to the Nov. 3, 2020, election. The complaint relied on videos posted to social media and a story by conservative website Newsmax as evidence of a conspiracy to "destroy, delete, secrete (sic), alter, hide and/or obscure election data, materials, equipment, and/or the product of same, and/or the results reflected thereby in order to prevent the discovery of the fraudulent results of the November 3, 2020, election, and violation of various state and federal election laws." In May, Delaware County District Attorney Jack Stollsteimer issued a letter stating that a special criminal investigation into the 2020 elections was now closed, no charges would be filed and determined that the allegations of fraud were "complete fiction." During Wednesday's County Council meeting, Delaware County Solicitor William F. Martin noted that the case is no longer active in Common Pleas court. "Just in case anyone wonders whether this was a result of any partisan determination, I will point out that the judge on the matter was Judge John Whelan," Martin said. "Judge Whelan was a member of (Delaware) Councy Council from 2006 to 2013, elected as a representative of the Republican Party. He was elected as a Republican District Attorney from 2014 to 2017 and elected as a member of Common Pleas Court as a Republican candidate in 2017."

Martin said the judge reviewed the materials after the case was assigned to him on June 1. "(Whelan) took less than 30 days to conclude that it was moot and he dismissed the matter," Martin said."
